On October 21, 2020 at 7:04pm, the regular meeting of the Board of the Bone Mesa Domestic Water District was held. This meeting was called to order at The Living Farm Education Center by Tom Gillespie, President. Andrea Wang, Vice President was present, establishing a quorum. Viva Kellogg and Mitch Morgan were also present. Leslie Malek-Madani and Travis Loberg were absent.

Tom opened the **Public Hearing for the 2021 Budget** at 7:05pm. The Board members reviewed the budget and confirmed that the budget looked complete.

The Board directed Viva Kellogg to prepare the resolutions for the November board meeting. Tom closed the public hearing at 7:18pm and re-opened the regular meeting.

Public Comments: There were no public comments.

September income was \$11,316.66 plus \$51.32 interest income, expenses were \$3,494.19 and net income was \$7,873.79.
